## A bit about what we do

Most of us will encounter, at some point in our lives, a moment when we need a helping hand. This can come through illness, or redundancy, or relationship breakdown, or sudden disablement, or retirement.

It might be caused by crime or injustice, or having to flee civil war and make a new life in a new place. It might simply be discovering how complicated the benefit system is and needing some expert guidance to find a way through it.

These are the times when skilled and independent advice can help. Advisers at St Pauls Advice Centre (SPAC) support people to get control over their debts, to straighten out benefit difficulties, correct mistaken judgements, rescue homes from repossession and regularise immigration status.

Sometimes a phone call is all that's needed; at others, extensive work with individuals and families over a period of time. Our practical support helps people to gather up the threads of their lives and move on again.

We inform people of their rights and obligations, and of services available to them – helping them to secure their rights.

## Achievements in 2010-11

**Secured funding for continued advice services** across east Bristol, in partnership with East Bristol Advice Services and Bristol City Council.

**Collaborative work with other agencies** succeeded in bringing over £700,000 per year into Bristol from the Legal Services Commission for supporting advice needs.

**Established future funding** to expand home visits and outreach services in a local health centre, following completion of a three year Big Lottery funded project.

**Continued to be at the forefront of bilingual advice** with our Somali Advice Project for Bristol's new Somali communities.

**Face-to-face debt advice helped people gain control** and manage their debts in a climate of financial insecurity.

**Information, help completing forms and referrals** were given to more than 1000 people by our reception staff.

Need for face-to-face support can only grow in the next few years. SPAC will continue to argue for high quality, free advice for all, and to develop new and innovative ways to deliver it.

## Amina's story

Amina suffered from severe mental health problems: panic attacks; depression; memory loss; suicide attempts, by overdose & hanging; self-harm, by cutting herself & banging her head against walls.

She came to us because her home was at risk due to rent arrears and her case was due to be heard at court.

Our debt adviser was able to avoid repossession by securing an adjournment at court. Our benefits adviser identified long standing problems with Housing Benefit that had caused rent arrears. We discovered gaps in Amina's entitlement and that benefit had been suspended.We negotiated on her behalf and helped to lodge an appeal.

As a result Amina was paid Housing Benefit that she should have received previously. This sum cleared her rent arrears and put a stop to further possession proceedings, providing the security she needed.

We also assisted Amina to claim Disability Living Allowance. When awarded, her income increased by over £93 per week which helped her to receive the care and improved living conditions that she so badly needed.

## The year in numbers

97% of clients would recommend our service to others.

**£1.3m** We helped several hundred people manage £1.3m worth of debt.

**£500,000** Our advice brought more than half a million pounds into the community.

83% About 83% of the people using our services are from black and ethnic minority communities.

2,282 We dealt with 2,282 enquiries during the year.

# 72% of people we advised said that our help had improved their situation.

**£294, 105** Our annual turnover for 2010/11 was £294,105.



# Abdullahi's story

In 2001 Abdullahi's home in Somalia was attacked by militia. His father was killed, his sister was raped, and Abdullahi was beaten with guns. He escaped Somalia as he believed he would be killed.

Abdullahi sought asylum in the UK. He moved around the country using vouchers to pay for food. His asylum claim was refused and any form of support was withdrawn.

In 2003 Abdullahi moved to Bristol, married and subsequently had two children. We helped the family to claim what benefits they could, but because of Abdullahi's immigration status he was not entitled to benefit in his own right. Therefore the family were struggling on a very low income.

We referred him for specialist immigration advice and indefinite leave to remain in the UK was finally granted in 2009.

In 2011 we helped him apply for British citizenship and he now has a British Passport.

Abdullahi says he felt like a prisoner as he knew he could not travel even if he had the money to do so. After 10 years he now feels secure. He can work, make more of his life, and travel knowing that he can return safely to Britain.
